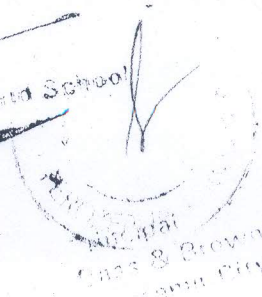
In response to the subject cited above

After taking into consideration the documents and affidavit produced by the management of the school and the recommendations made by District Education Officer (SE), Ferozpur and Director, Department of Education (SE), Punjab, Chandigarh, the NOC is being issued by the Punjab Government on the conditions given below:-

1. In case it is found during any inspection that the school has given false information to the state government for the NOC, or the school is not following the instructions laid by the state government issued from time to time or if the school is not fulfilling the conditions given in writing in the affidavit, the NOC may be withdrawn.
2. Punjabi will be taught as a compulsory subject upto X Class in the school and the CBSE, New Delhi will take an initiative to make it compulsory to conduct the exam of Punjabi language in such schools. The NOC shall be withdrawn in case the same is not followed.
3. School Management will strictly follow the notification issued by Department of Education, Government of Punjab under R.T.E. Act 2009 and the norms of the State of Punjab under R.T.E. Act 2009

4. After getting the affiliation of CBSE, New Delhi, the management of the school will be committed to give salaries and other benefits to the teaching and non-teaching staff as per government norms and through cheques failing which the NOC can be withdrawn
5. You and the school management will make sure that if the District Education Officer or any other senior official from the Department of Education demands some information, it will be provided to him/her with full cooperation failing which the NOC can be withdrawn.
